They will also be able to post events and be active on the website.

I hereby irrevocably grant the Association permission and license to (a) use my name, business or organization name, names of the employees and members of my business or organization, and any likeness thereof in any marketing materials, advertisements, endorsements, and other materials as the Association may determine; and (b) post any letters and comments the Association may receive from customers, clients or anyone else to be posted and made public (whether or not they place me or my business or organization in a favorable light).
